The manufacturing and packaging of hard frozen dairy product novelties shall be done when the establishment is closed to the public. A one time fee is required for the issuance of the initial **Limited Packaging Permit** for the amount of **\$300.00**

An annual onsite evaluation of compliance with specific permit conditions shall be completed by the inspector prior to the renewal of the **Limited Packaging Permit**. An Annual Renewal Fee for this permit is **\$150.00**. Renewal fee is due January 1 and if not postmarked by February 1, there will be a 25% penalty.
