

SUBJECT: **ADDENDUM NUMBER 1 FOR THE REQUEST FOR PROPOSALS FOR
PAROLEE SERVICES NETWORKS**

This is Addendum Number 1 for the Request for Proposals for Parolee Services Networks – May 2008.
Please be advised of the following revisions:

Section VI. SCOPE, D. Funding, paragraph 3, page 9, revised as follows:

Residential services shall each have a capacity of six (6) slots per twelve (12) month fiscal year cycle, ODFC services shall each have a capacity of twelve (12) slots per twelve (12) month fiscal year cycle, and ADFLC services shall each have a capacity of two (2) slots per twelve (12) month fiscal year cycle.

Please be advised of the following responses to questions from the Proposers' Conference held on May 20, 2008.

- 1. Will the California Department of Alcohol and Drug Programs consider any cost of living increase in bed/day rates?**

No. Proposers must use the State approved rates as described in the Request for Proposals for Parolee Services Networks on page 10, E. Method of Payment for determining staff and other operational costs.

- 2. On page 11 for outpatient services it states 1½ to 3 hours of face to face. Why has this changed from 1 to 3 hours?**

The hours of service listed on page 11 are consistent with the Parolee Services Networks Program Guidelines and Treatment Standards, which were developed by California Department of Corrections and Rehabilitation.
