Nurse Only Clinic Registration Schedule

Due to COVID-19 activities, all DPH Nurse Walk-In Clinics will be closed until further notice. Effective 01/06/2021.

Please note: All schedules are subject to change. Clinics are closed to observe all County holidays. Patients should be advised to call the clinic to confirm that a particular session is being held. Please call to make a scheduled appointment and arrive 15 minutes prior to your appointment. Limited walk-in appointments are available on the same day. Walk-in patients should arrive as early as possible to improve the likelihood of being seen.

Nurse Only Clinic provides all required childhood immunizations and Mantoux (TB) skin test. There is a \$15 vaccine administration fee per patient for each visit in our Nurse Only Clinic and \$30.00 for families of two or more. This fee covers all vaccine for that visit. If the child has Medi-Cal or MediCare plan, the cost is free as long as the patient can provide the Medi-Cal coverage card at the time of registration.
