SUBJECT: CHDP PROVIDER UPDATE #01-2020

### I. ACEs Screening

Beginning January 1, 2020, DHCS will pay providers \$29 per trauma screening for children and adults with Medi-Cal coverage. By July 2020, providers must self-attest that ACEs Aware training has been completed in order to be eligible to continue receiving Medi-Cal payment for conducting ACEs screenings. Proposition 56 Trauma Screening Policy Highlights:

- Effective Date: January 1, 2020
- Target Population: Children and adults up to age 65 (excludes those dually eligible for Medicare and Medi-Cal)
- Provider Types: All
- Healthcare Common Procedure Coding System (HCPCS) Codes: G9919 (positive screen with patient score of 4 or greater); G9920 (negative screen with patient score of 0 to 3)1
- Rate: \$29

#### II. <u>Developmental Screening</u>

For Fiscal Year (FY) 19-20 the Governor's Budget included \$60 Million (50% Proposition 56 Funds/50% Federal Funds) to support developmental screenings on an ongoing basis for all children with full-scope coverage in Medi-Cal. Providers completing screening with a validated screening tool that meets AAP criteria (see attached bulletin) and billing with the CPT code as below will be reimbursed at the FFS rate of \$59.90. CHDP offered provider trainings to become available in the fall of 2020.

Proposition 56 Developmental Screening Policy Highlights:

• Effective Date: January 1, 2020

• Target Population: Children up to age 30 months (excludes those dually eligible for Medicare and Medi-Cal)

Provider Types: AllCPT Code: 961101Rate: \$59.90

#### III. Trainings Reminder
