Patrons who ate at Jerry's Deli, Westwood, on November 18, 21, 23, or 24, 2010

Due to a risk of exposure to hepatitis A, patrons who ate sandwiches at or from Jerry's Deli in Westwood, located at 10925 Weyburn Avenue, Los Angeles, on November 18, 21, 23, or 24, 2010, are urged to receive an immune globulin (IG) shot or a hepatitis A vaccine no later than 14 days from the date they visited Jerry's Deli to prevent or reduce illness. Please note that only the Westwood branch of Jerry's Deli was affected.

Affected residents are encouraged to seek treatment through their personal physicians. The Department of Public Health will make the IG shot and hepatitis A vaccine available through the walk-in clinics listed below on the dates and times shown, through December 8, 2010.
