**Note for your protection:**

All General Certified Backflow Testers

- are required to provide a LA County Backflow Tester Wallet Photo ID Card. Ask to see it and verify identity of the tester.
- are required to have liability insurance as part of their contractor 's license. Report anyone without a contractor 's license to this department (626)430-5293.
- are required to submit all completed, original test notices back to the owner of the backflow device. This ensures the timely submittal of the test notice as well as a means to track work performed
