Reopening Safer at Work and in the Community for Control of COVID-19 Order: Examples of What's Open in Los Angeles County

Through our Safer at Home efforts, we'd slowed the spread of Novel Coronavirus (COVID-19) in Los Angeles County, allowing for a phased reopening of some businesses and public spaces. However, there have been troubling increases in cases and hospitalizations and COVID-19 remains a serious risk. It is crucial that you practice physical distancing and wear a cloth face covering whenever you are or may be around others, and wash your hands frequently, to help prevent serious illness and death. Also, remember to stay home [if you are sick](#) or if you have been in [close contact with someone who is sick](#).

CLOSED FOR NOW

- Arcades, Bowling Alleys, and Movie Theaters
- Bars, Breweries, Brewpubs, Pubs, Wineries, and Tasting Rooms (Except for Retail Sales, which Can Be Open)
- Baseball & Soccer Fields & Basketball & Volleyball Courts
- Beaches and Piers (Piers are Open Only for Restaurants) *These are temporarily closed between July 3 and July 6.*
- Cardrooms, Satellite Wagering, and Racetracks with Onsite Wagering
- Festivals and Theme/Amusement Parks (including Water Parks and Splash Pads in these Parks)
- Hot Tubs, Jacuzzis, and Spa Pools (If Not at a Residence)
- Live Performance Theaters and Concert Venues
- Lounges and Nightclubs
- Stadiums and Arenas (Closed to the Public)
- Youth Sports Leagues

Shopping, Restaurants, and Personal Care CAN BE OPEN

- [Grocery Stores, Supermarkets, Certified Farmers' Markets, Farm and Produce Stands, Food Banks, Convenience Stores, Wholesale Clubs, and Pharmacies](#)
- [Hair Salons and Barber Shops](#)
- [Lower-Risk Retail Stores](#), such as Bookstores, Jewelry Stores, Furniture Stores, Toy Stores, and Clothing Stores
- Pet Food Stores, Animal Daycare and Boarding Facilities, and Veterinary Clinics
- [Restaurants and Cafés](#), but only for Delivery, Drive Thru, Carry Out, and Outdoor Sit-down Meals Only (Indoor dining is closed.)
- [Personal Care Services](#), with Limited Occupancy: Nail Salons, Tanning Salons, Esthetician, Skin Care, and Cosmetology Services; Electrology, Body Art Professionals, Tattoo Parlors, and Piercing Shops; and Massage Therapy (in Non-Healthcare Settings)
- Stores that Sell Products Needed for Your Home, such as Hardware, Building, Home Appliance, and Pool Supply Stores

CAN BE OPEN: Clinics, Hospitals, Dental Clinics, Physical Therapy and Chiropractic Offices, Optometrists, Mental or Behavioral Health Providers, and other Healthcare Settings
