- Andrea Welsing described the origins and 6 Strategic Priorities of OVP as well as a description of programs. Ms. Welsing addressed the current political environment and the need to increase awareness, continue to collect data and maintain a steady focus on the work. She acknowledged that community members are reporting/experiencing fear and that may cause them to go "underground".
- Ms. Welsing urged members to take back information learned in this forum to their communities and for this Council to assist in the work of OVP to build a roster/network of services.
- Ms. Welsing, call for questions:
 - Member question: What support can Council members expect from the County/OVP?
 - Ms. Welsing answer: GBV funding (tranche 1 & 2), data sharing and evaluation support, resources and brochures, expertise, trauma informed support, community messaging

11:12a-11:56a LAC SAC ED provided a brief presentation on tag line ideas and priority areas identified from April 28, 2025, LAC SAC strategic planning meeting. Below are member responses from the following categories:

Cultural Inclusion, Awareness and Practices

- "Disabled/developmental disabilities" not inclusive descriptions
- Missing: Sex trafficking, Incarcerated/PREA, Deaf/hard of hearing, Vets, POC, and other marginalize groups
- "Native Americans" includes indigenous
- Youth:
 - Can age groups be better defined
 - Children and youth/teens and infants
 - To define age there should first be consideration of a goal; what are we trying to achieve
 - Council should look at Board directive to determine intentions for 1) prevention/intervention/healing 2) Gaps 3) Definitions of pops
 - o Explore potential for sub-categories for youth vs as a more general idea
 - Data/stats of different age groups, genders; assess who needs what to define what "youth" means to the Council
- Include patient abuse in healthcare settings
- Categories can all have a deeper dive by creating sub-committees to unpack the true definitions. Start with a goal/purpose to know how to define and address
- DV/SA what is the intersection. Must review data; and to determine need.
- Add men/boys' voices
- Provide a timeline of LAC SAC Board Report Backs to develop master calendar

Training, Education and Awareness

• Focus on where the problems are e.g.: Greek life, athletics, etc.

Item Action Lead

- Training for LE and security guards. Security guards should get bystander training
- Expand bystander training from bars only in WEHO to LACO
- Support Rape Crisis Centers that lack funding
- Conduct a landscape analysis of trainings and maintain a roster
- Develop strategy for marketing trainings
- Develop an info booklet/digital to include description of services, steps involved in the process "what to expect/next". Include what to expect in person and for virtual options
- Cultural sensitivity training for service providers on survivor experience; Health Care/DA; include eliminating judgement
- Advocate for unarmed crisis response
- Educate the community on role of LE
- Ensure follow through, transparency, warm hand-offs, empathy and trauma-informed care
- Include survivor's voices
- Determine Council training needs; what is needed, where are the gaps
 - o Council to hear from Rape Crisis Center to understand the scope of service
 - o Hear from providers: Where is the system failing
- Consider burnout of providers/LE
- Explore the idea of "where the real work starts" e.g., with case managers, how to get the appropriate information to them. Explore avenues to communicate one-on-one with providers
- Consider mandated reporting and confidentiality in training curriculum
