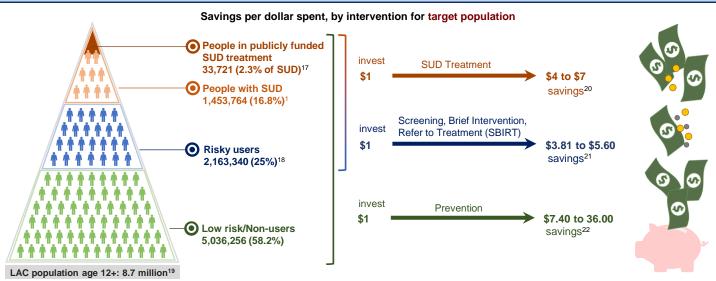

- In 2024, an estimated 16.8% of the US population aged 12 or older had a substance use disorder (SUD).
- Young adults aged 18-25 years had the highest prevalence of alcohol and other drug (AOD) use and use disorder among all age groups.
- An estimated 1,453,764 people aged 12+ in Los Angeles County (LAC) population needed SUD treatment, based on the 2024 US SUD prevalence (16.8%) and the average annual population aged 12 or older in LAC for 2020-2024.

- Tangible costs of SUD, including medical, wage and household work, public services, property damage, and motor vehicle crash costs, amounted to nearly \$13 billion (\$9.5 billion for alcohol and \$3.4 billion for illicit drugs) in LAC in 2012.

- On average from 2020-2024 in LAC, there were 4,045 deaths each year that listed an AOD-related underlying cause of death on their death certificates, accounting for 5.3% of all deaths.
 Note: AOD includes all drugs, including for therapeutic use.

- On average from 2019-2023 in LAC, there were 140,500 ED visits, and 141,275 hospitalizations that listed an AOD-related condition as the principal or other diagnosis or external cause of injury each year. Note: AOD includes all drugs, including for therapeutic use.
- The mean charge per AOD-related hospitalization in 2019-2023 was \$121,256, totaling about \$17.1 billion each year. All costs were adjusted for inflation to 2024 US dollars.

- The average annual cost to incarcerate an inmate in California prisons was \$127,788 in the 2025-2026 enacted budget. This includes expenditures for security, inmate health care, facility operations and records, administration, inmate
- food and activities, rehabilitation programs, and other costs.

 Nearly three-quarters (74%) of these costs are for security and inmate health care, while 4% were for rehabilitation
- The average annual cost increased by about \$78,900 (161%) since 2010-2011. The higher costs in 2025-2026 were driven by court orders related to health care and employee compensation.

- Among inmates incarcerated at federal or state prison or county jails in the US, 65% meet medical criteria for an SUD; 25% were incarcerated for drug law violations, including possession or use, trafficking, or other unspecified substance offenses; and 43% were under the influence of AOD at the time of the crime.

- On average from 2020 to 2024 in California, there were a total of 292,574 AOD-related arrests each year, of which 21,779 were for felony offenses (narcotics, marijuana, dangerous drug, and other drug law violations), and 270,795 were for misdemeanor offenses (driving under the influence, drunk, and drug offenses).
- On average from 2020 to 2024 in LAC, there were a total of 4,403 felony offenses, accounting for about 20% of the state total.

- Substance use and addiction accounts for about 19.5% of the California state budget. In 2005, \$7.7 billion, or 82.2% of the total justice (adult corrections, juvenile justice, judiciary) spending in California was related to substance abuse. Government spending for substance abuse for prevention and treatment was 339 million (1.7%), compared to the \$19.5 billion (98%) in spending on its consequences in California.

- In 2024, 12.6% of US young adults aged 21-25 reported driving under the influence of alcohol or illicit drugs in the past year.
- In 2024, among US adults aged 18+ years, 29.1% full-time employees and 29.5% part-time employees reported using illicit drugs in the past year. Past year illicit drug use was highest among young adults aged 18-25 years at 42.0% of full-time employees and 37.8% of part-time employees.

- In LAC, on average from 2017-2021, there were 22,134 arrests for driving under the influence of alcohol or drugs (DUI). About 67% of DUI arrests were convicted. There were an average of 15,475 DUI convictions per year from arrests in 2017-2020.

- According to CHP, DUI cases can cost about \$13,500. DUI costs include vehicle towing and storage (\$187); booking, fingerprinting, jail costs (\$156); fines (\$468); penalties (\$780); attorney and legal fees (\$2,557); car insurance increases (\$8,652); DUI victim funding (\$100); driver license reinstatement (\$100); and DUI classes (\$500).

- Nearly a quarter (23%) of the US adult workforce reported being exposed to a coworker who had used or was impaired by alcohol during the workday in the past year. About 13% were exposed to cowoker who was impaired or using illicit drugs during the workday in the past year.

- Workers with an alcohol use disorder were 3.6 times more likely, and workers with an illicit drug use disorder were 5.8 times more likely to have job-related effects (tardiness, absenteeism, loss of productivity, workplace injuries, and traffic incidents during commute, conflicts with coworkers, and sanctions by employers).
