#### **Network Adequacy:**

- Part of the Final Rule
- Standards include: Time, Distance & Access to Care

#### State Requirement:

 All DMC-ODS providers are required to submit Network Adequacy data annually





## **Important Dates**



**January 28, 2020** – Treatment providers identify and submits form for Agency Point Person(s) for 2020 NACT Reporting

**February 7, 2020** – Agency provided their unique login info.

February 14 & 19, 2020 – SAPC will conduct on-line training

**February 18, 2020** – SAPC will conduct in person training.

**February 20, 2020** - Online application opens for all treatment providers to review and input data.

**February 21-March 10** – Daily Skype calls will be open for provision of technical assistance will be provided.

March 10, 2020 – Submission Deadline

**March 10-25, 2020** – Data validation. SAPC will contact Agency Point Person with any questions, corrections or clarifications

#### **NACT Web Application**

 Provides a streamline method for providers to submit network adequacy information

#### **Accessing NACT Web Application**

 Log-in information will be provided to the agency identified point person(s)

#### **Trainings & Technical Assistance**

• SAPC staff will provide webinars, in-person trainings, and support with any technical issues for provider network.





# Things to Remember: SAPC Treatment Providers

#### Requirements:

- All providers who provide DMC-ODS Services must submit
- Information must complete up-to-date data for organization and site location
- Web browser required for NACT will be Google Chrome

#### NACT Information Request:

- a. Organization Information
- b. Site Locations
- c. Practitioners Information
- d. Language Fluency
- e. Cultural Competence training
- f. Type and number for license/certification



#### Network Adequacy Application

Provides a method for all providers to submit and update information for network adequacy, cultural competency, and the provider directory.

#### Applicable to:

- All Outpatient Providers who provide Mental Health Services, Medication Support Services, Targeted Case Management and/or Crisis Intervention
  - Must keep all sections at the Organization, Provider Site and Practitioner Level up-to-date
- All Other Providers who provide only Inpatient Services, Residential Services, Crisis Stabilization, Day Treatment Intensive, Day Rehabilitation, and/or Community Outreach Services
  - · Must keep Organization and Provider Site information up-to-date
