Substance Use Disorder Workforce Development

Goal: Implement a Substance Use Disorder (SUD) Counselor tuition incentive program
(TIP) inclusive of education and practicum to enhance the SUD workforce in Los Angeles
County.

• <u>TIP</u>

 Provides an opportunity for individuals with lived experience to access subsidized education in Substance Use Treatment.

Education Component

- Tarzana Treatment Centers College (TTCC) six (6) month Coursework Component
- Practicum- supervised fieldwork for students to observe and practice key theories learned in class.

Internship Implementation Activities:

- Meet requirements to supervise Registered Counselors
- Submit an interest form to TTTC
- Short training on Preceptorship
- Memo of Understanding of requirements and expectations



Benefits to becoming a Internship Placement Site

- Reduce Turnover and associated Recruitment and Onboarding:
 - SUD Interns are viable candidates for full-time roles as counselors and SUD technicians at your agency.
- Additional Funding to Support Your Workforce:
 - All SUD student interns are registered and can provide billable DMC/SUD services once trained.
 - Receive increased outpatient rates when counselors become certified
 - Be eligible for the additional workforce incentive payment when 40% or more of your counselor workforce is certified.

In Addition participation in these efforts should improve your ability to meet incentive 1-a Metric: At least 50% of SUD Counselors providing direct services are certified SUD Counselors- \$30k (Tier1); \$45k (Tier2); and \$60k (Tier3). More info here.



What is Practicum?

What is...

- **Practicum** is how students gain supervised fieldwork in substance use counseling.
- Preceptors are on-site instructors that work with the interns from the TIP program at TTC College.
- Placement sites- SAPC Network Provider
 Agencies that provide on-site internship
 opportunities for TIP students to safely
 practice the 12 core functions of addiction
 counselors.

Expected Outcomes:

- Arrange an orientation for students that covers essential functions of your agency's treatment program.
- Allow students the opportunity to practice and accomplish practicum objectives
- Abide by ethical principles

Qualified supervisors have ANY of the following credentials:

Active Certification:

- CADC (I,II), CCAPP CCS, IC&RC ICCS, LAADC, or LAADC-S.
- CATC (I-II-III-IV-V or N)
- SUDC (II-III-IV), SUDC III-CS, or SUDC IV-CS

OR

 9 or more years of SUD counseling supervision experience

OR

Degrees in a Behavioral Health (BH) Discipline

- Associate's degree and seven (7) years of supervised experience in delivering counseling services with the 12 Core Functions of substance use counseling
- Bachelors degree and five (5) years of supervised experience in delivering counseling services with the 12 Core Functions of substance use counseling
- Master's degree and three (3) years of
- supervised experience in delivering counseling services with the 12 Core Functions of substance use counseling
