To support Provider networks' ability to offer overdose prevention and education services to individuals services at their facilities.


#### **Activities:**

- Two (2) 4mg doses of Naloxone Nasal Spray
- \* Two (2) Fentanyl Strips
- Testing for Fentanyl
- Printed materials
  - Good Samaritan Card
  - Naloxone Prescription Card
  - Fentanyl precaution card
  - Overdose First Aid Manual

- Delivered before October 1<sup>st</sup>.
