# Behavioral Health Bridge Housing (BHBH) Grant



## **BHBH** Overview

- The California Department of Health Care Services (DHCS) will award Behavioral Health Bridge Housing (BHBH) program funds to California's county behavioral health agencies.
- ➤ The funding will be used to address the immediate housing needs of people experiencing homelessness who have serious behavioral health conditions, including a serious mental illness and/or substance use disorder (SUD).
- Total funding available for Los Angeles (L.A.) County is \$321,189,238 out of the initial grant rollout of \$907,936,000 with potentially more funding awarded to LA County after initial rollout.
- > The grant provides funding starting in FY 23-24 through June 30, 2027.



## Allowable Uses of Funds

>75% of funding to be spent in Bridge Housing category which includes:

- Shelter/Interim Housing
- $\circ$  Rental Assistance
- $\odot$  Board and Care Patches
- $\circ$  Navigation Services

The remaining funds can be spent on:
 Outreach Engagement
 Infrastructure Costs
 Program Implementation
